

# **Somerset Application for Free School Meals**

#### How do I qualify?

Parents and carers who receive any of the following are entitled to free school meals:

- Income Support (IS)
- Employment and Support Allowance (Income Related) not Contribution related
- Income-based Job Seekers Allowance (IBJSA) not Contribution based
- Guaranteed Element of State Pension Credit.
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit with an annual taxable income (as assessed by HMRC) of less than £16,190 as long as the family are not also in receipt of Working Tax Credit.

If you have recently become unemployed, but are still receiving Working Tax Credits, you may be entitled to free school meals. Please phone us on 0300 123 2224 for advice.

Only the benefits listed above qualify for free school meals. No other benefit entitles the parent or carer to free school meals for their children.

## How do I apply?

- 1. Please complete the attached form and send it to: Entitlements Team, County Hall, Taunton, TA1 4DY.

You do not need to send evidence with this application. If we need evidence at a later date we will contact you.

## What happens next?

We will enter your details onto an online system which will tell us whether you are entitled or not. We will tell you of the outcome, usually within 5 to 10 working days of getting the application. If you are eligible, we will tell you how to start receiving free school meals.

#### **Important**

You no longer need to reapply for the same children as long as you remain entitled. Once we have your details on record we will do regular checks to see whether you are still entitled. To perform these checks we need up to date details. Therefore, you must let us know of any changes of benefit, name or address of the person in your household receiving the qualifying benefit. Incorrect details may lead us to believe that you are no longer entitled to free school meals. You can either tell us by writing to the Entitlements Team, County Hall, Taunton, TA1 4DY, phoning the helpline number 0300 123 2224, or by emailing <a href="mailto:freeschoolmeals@somerset.gov.uk">freeschoolmeals@somerset.gov.uk</a> You will need to submit a new application for any children you haven't previously applied for.

#### What is covered?

If your child is entitled to a free school meal, but requires a special medical diet we can arrange for an appropriate meal to be provided. You will need to ask your doctor to write a letter explaining which foods must be avoided.
